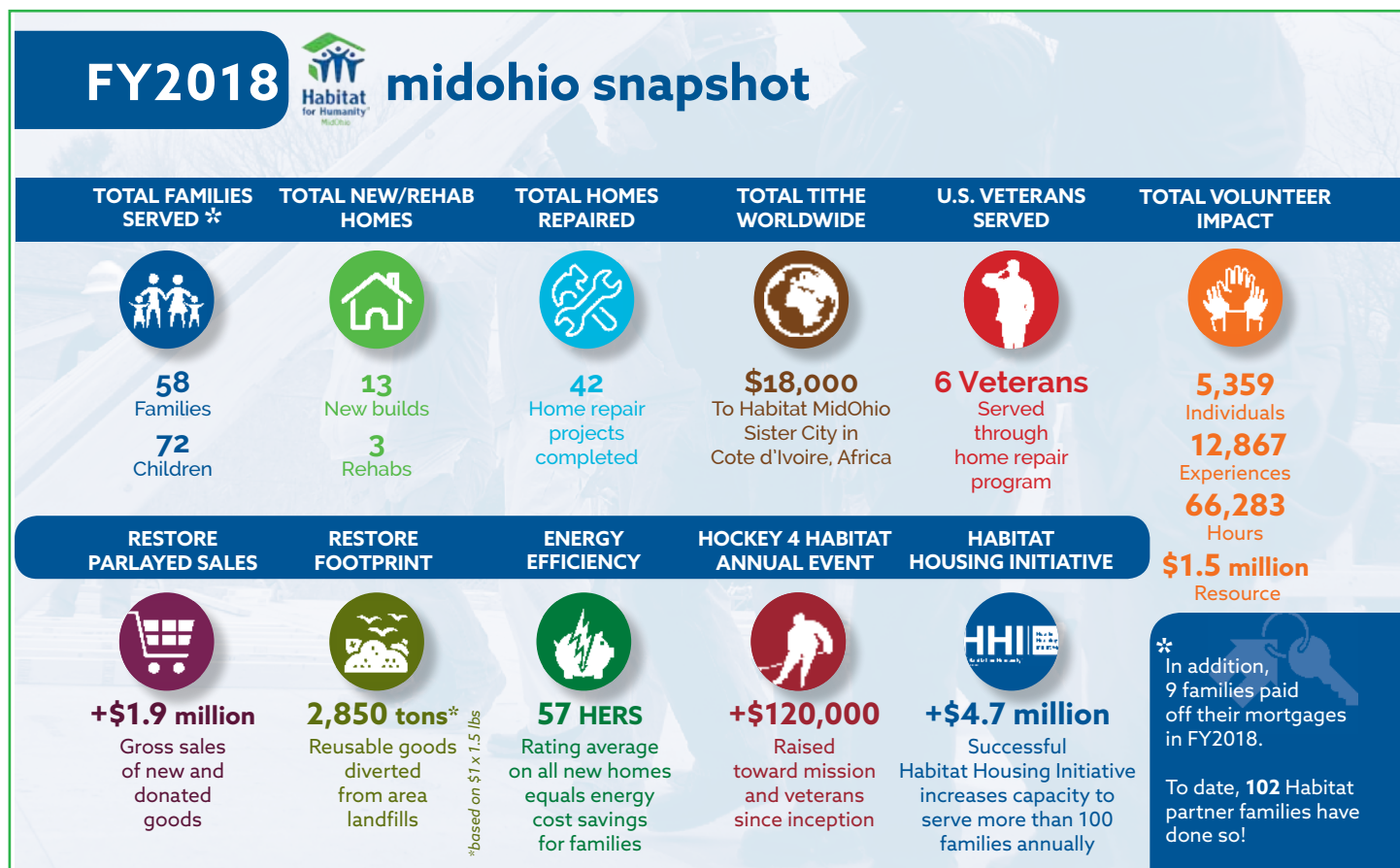

than 100 annually!
